### Computing Floorbook 2024-25

At St Matthias, we want to give children the skills to safely use the internet and to be able to adapt to technology that is constantly evolving. We want to prepare children for life beyond our school, ensuring they know the exciting opportunities, as well as the challenges and risks, of using the internet. Through following online safety strands set out in the [Education for a Connected World framework](#) and underpinning our computing curriculum using the [National Centre for Computing Education's Teach Computing](#), we are ensuring our children are confident in the three main strands of computing: information technology\*, digital literacy\*\* and computer science\*\*\*. **For guidance, see [KS1 and KS2 Programmes of Study](#).**

\*Information technology = Children can evaluate and apply information technology, including new or unfamiliar technologies. This includes using things such as office applications and other software, as well as using the internet.


\*\*Digital literacy = Children are responsible, competent, confident and creative users of information and communication technology. They do this safely and responsibly.

\*\*\*Computer science = Children can understand and apply the fundamental principles and concepts of computer science, including abstraction, logic, algorithms and data representation; and can analyse problems in computational terms by writing computer programs.

It is vital that pupils are taught about the online safety strands outlined in the [Education for a Connected World framework](#); some of which are also taught in our PSHE lessons. These strands have been mapped into our yearly curriculum map - resources can be found in this document.

It offers strategies for effective searching, critical evaluation of data, the recognition of risks and the management of online threats and challenges. It explores how online threats can pose risks to our physical safety as well as online safety. It also covers learning relevant to ethical publishing.</p> | <br><b>Health, well-being and lifestyle</b><br><p>This strand explores the impact that technology has on health, well-being and lifestyle e.g. mood, sleep, body health and relationships. It also includes understanding negative behaviours and issues amplified and sustained by online technologies and the strategies for dealing with them.</p>                                | <br><b>Privacy and security</b><br><p>This strand explores the concept of ownership of online content. ## Computing systems and networks

This strand begins by explaining what a computer is. It also explores how networks can be used to retrieve and share information, and the associated risks that come with this. Learners begin by exploring what technology and information technology (IT) are, and then move onto exploring networks and the internet. Finally, they investigate how computing systems and networks help people communicate and collaborate.

## Programming


This strand looks at designing, creating, and evaluating algorithms and creating programs to allow computers to solve problems. In this strand, teachers introduce learners to a range of platforms, designing and making games and quizzes suitable for all year groups, and work towards controlling physical devices with computers.



## Creating media







## Data and information



Learners use a variety of different technologies to present data in graphs, spreadsheets, and databases, and also perform an investigation using a data logger.



